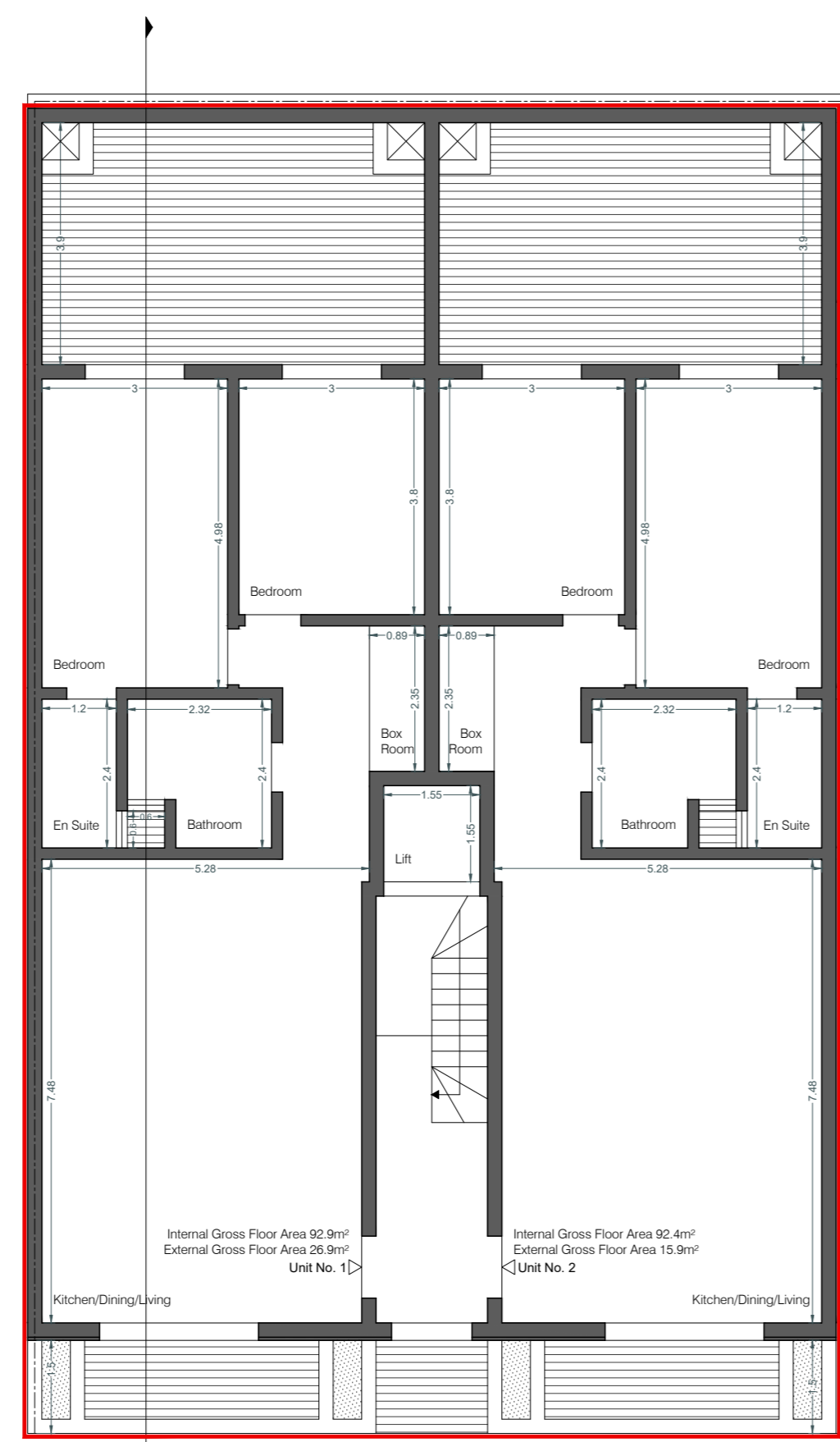
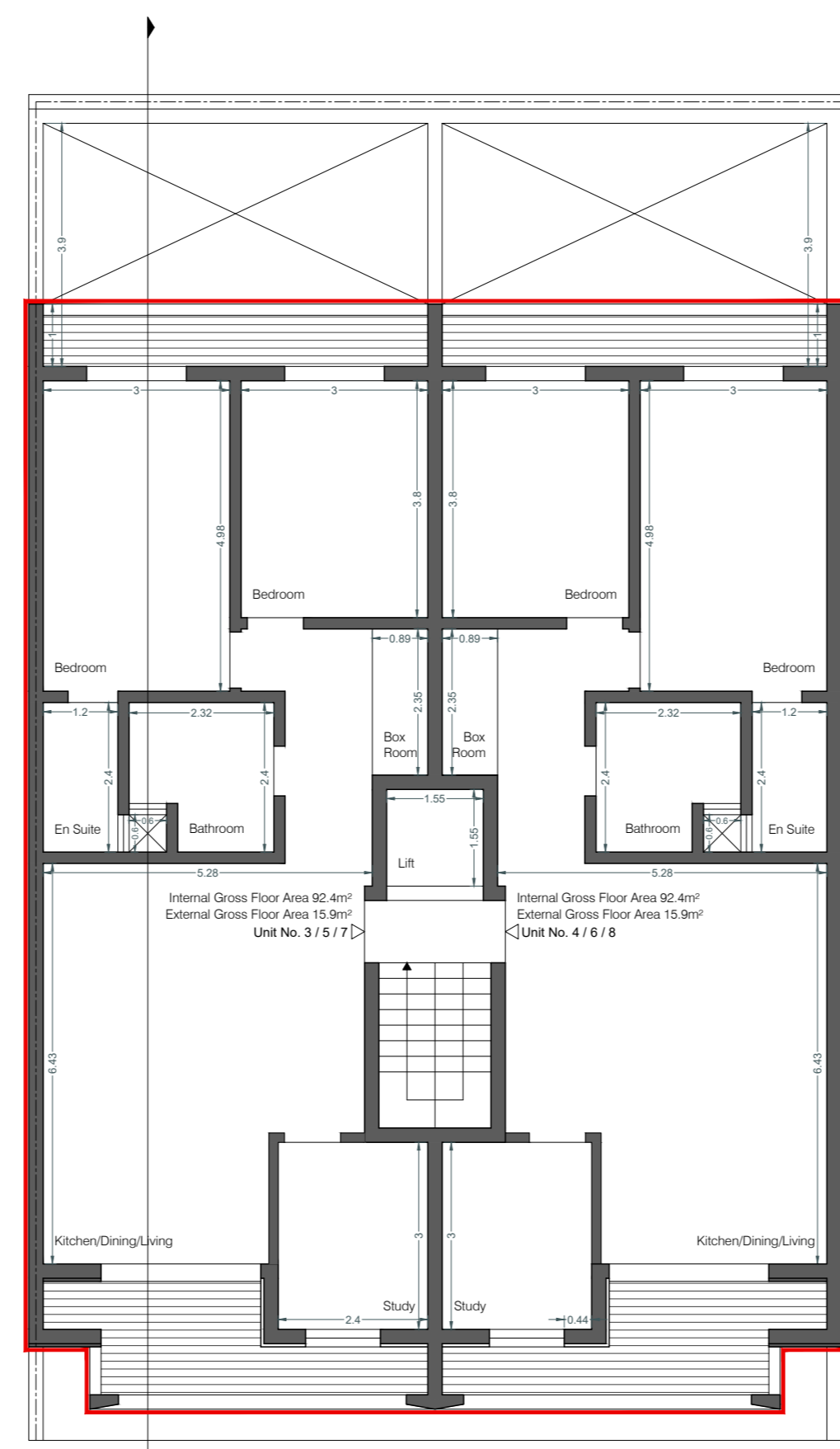


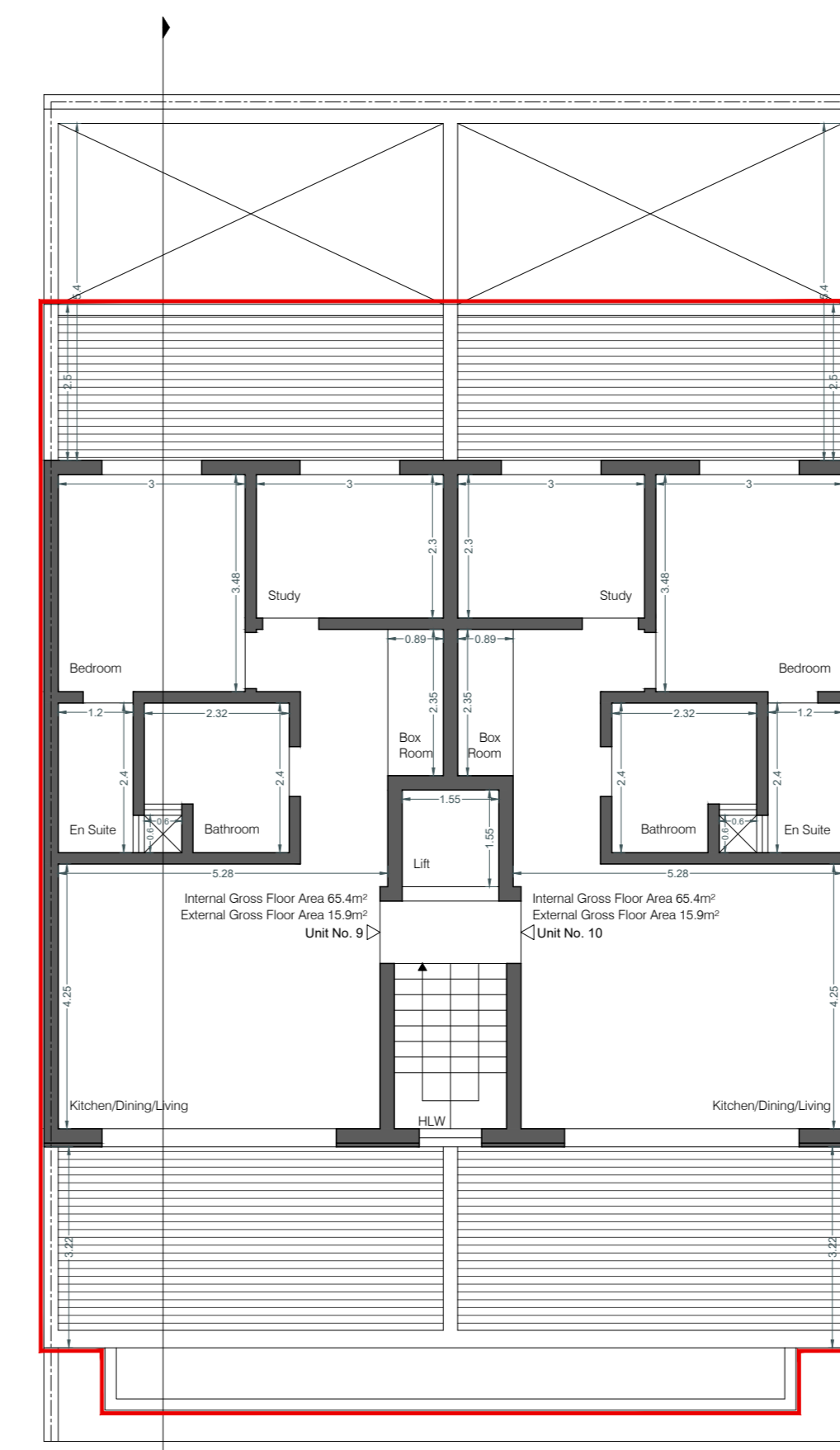
As Proposed Basement Floor Plan

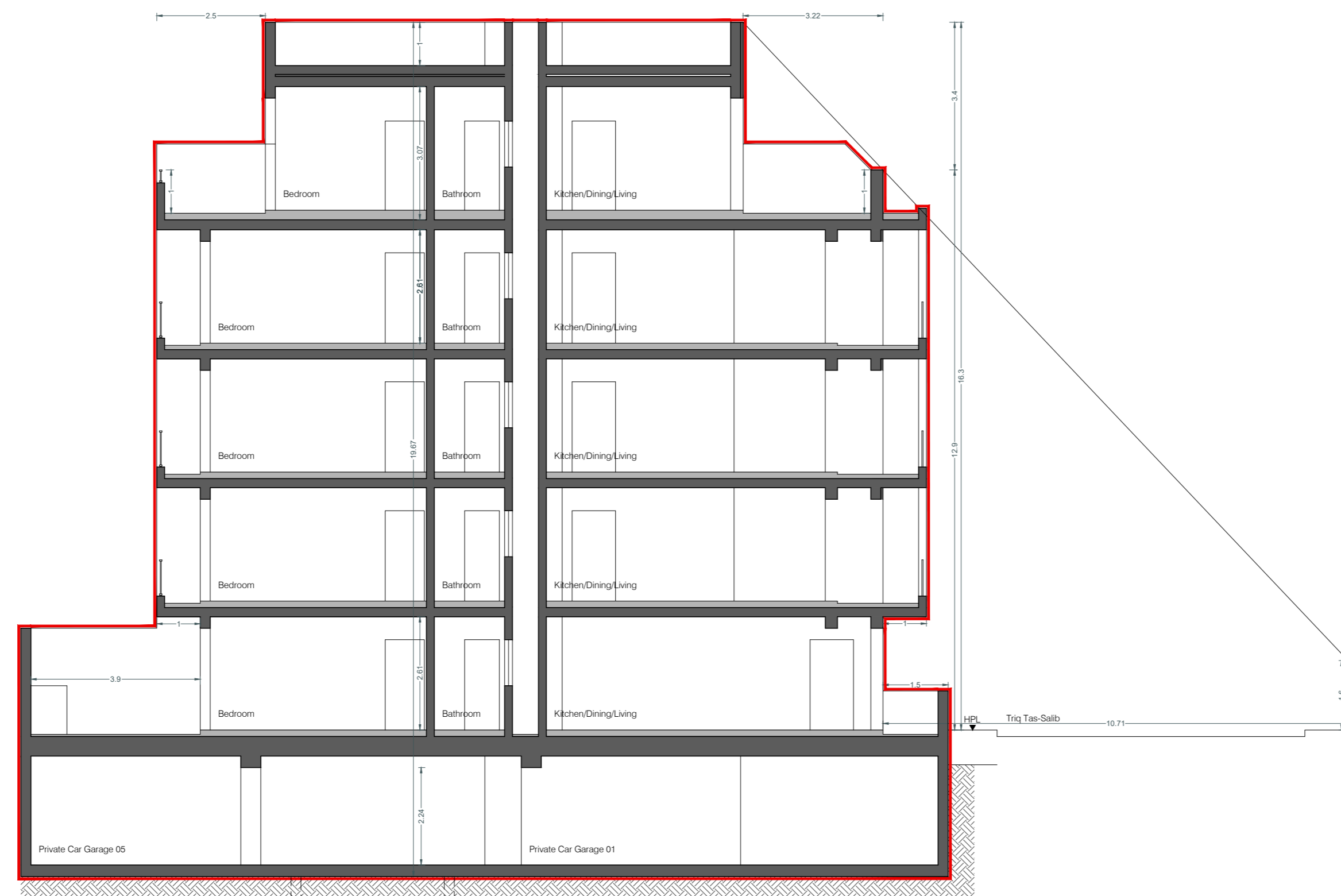
As Proposed Ground Floor Plan
